コロナ対策について

COVID-19: General information and conditions of participation:

Due to the Corona pandemic, special behavioral instructions apply and must be observed. We want you to feel comfortable and safe when attending our in-person events. Your health and that of our employees and event partners is very important to us, and there is a special duty of care among everyone involved at this time. To this end, we have compiled the following information and rules for you. They are intended as minimum requirements in addition to the rules, regulations and recommendations of the respective federal state.

The entry regulations of the Federal Republic of Germany and the Corona regulations of the Federal State of Hesse (Bundesland Hessen) in force at the time of the event must be observed.

In addition, the hygiene rules of the event location (hotel) and the organizer must be observed. In accordance with the official requirements, the following persons must stay away from the event:

- Persons who have had contact with persons infected with Corona in the 14 days prior to the start of the event.
- Persons who have respiratory or other symptoms known to be associated with Corona disease.

For participants in the events, please note:

- Proof of a current rapid test (max 24 h) is mandatory.
- The test obligation does not apply to vaccinated or recovered persons.
- o Vaccinated persons must provide proof of complete vaccination protection. At least 14 days must have passed since the last required vaccination.
- o Convalescents require proof of a positive PCR test or other nucleic acid test at least 28 days or max. 6 months ago.

Wearing of medical or FFP2 mouth/nose covering is mandatory (please bring masks). Appropriate on-site regulations must be followed. Hygiene measures on site are ensured by the organizer (e.g. provision of means for hand disinfection in the training and sanitary rooms). Rules of conduct in the room and during coffee and lunch breaks are pointed out on site (keep your distance, do not shake hands, hygiene measures, etc.).
